CANCELLATION POLICIES AND PROCEDURES

CANCELING YOUR MEMBERSHIP

You may cancel your membership upon 30-day written advance notice to Holistic Fitness [_____ (initial)]. All requests for cancellation of membership MUST be submitted in writing, and you are responsible for all membership fees incurred until you cancel your membership in accordance with the terms of this Agreement. We reserve the right to terminate or deny re-enrollment for an indeterminate amount of time if a customer has an unsatisfactory payment history. NOTICE TO CUSTOMER

1. Send a signed and dated written notice of cancellation by registered mail, return receipt requested, OR

If you cancel this contract within the three-day period, you are entitled to a full refund of your money less a fee equal to the value of any services received.
